# **Background**

In 2023, King County voters approved to create a new nine-year levy (2024 – 2032) to support the creation of five new regional crisis care center facilities distributed throughout the county, with one center focused on serving youth. More details on the CCC Initiative can be found here.

As outlined in the Crisis Care Center Implementation Plan, each competitive procurement process for operators of crisis care centers must be reviewed by a proposal review panel. The proposal review panel must include a scoring subject matter expert (SME) representative from the North, Central (chosen by Seattle), South, and East King County crisis response zone (see list and map below).

The Department of Community and Human Services (DCHS) defines subject matter experts as those with expertise in administering and/or delivering behavioral health or crisis services, considering both behavioral health organizations and individuals (like city staff) with relevant capital development project experience.

The Sound Cities Association has appointing authority to the proposal review panel for the following:

- 1. A <u>North King County crisis response zone representative</u> selected by the Sound Cities Association from cities to review crisis care center operator proposals for the north King County crisis response zone. (North zone includes cities: Bothell; Duvall; Kenmore; Kirkland; Lake Forest Park; Shoreline; Skykomish; Woodinville)
- 2. A <u>South King County crisis response zone representative</u> selected by the Sound Cities Association from cities to review crisis care center operator proposals for the south King County crisis response zone. (South zone includes cities: Algona; Auburn; Black Diamond; Burien; Covington; Des Moines; Enumclaw; Federal Way; Kent; Maple Valley; Milton; Normandy Park; Pacific; Renton; SeaTac; Tukwila)
- 3. An <u>East King County crisis response zone representative</u> selected by the Sound Cities Association from cities to review crisis care center operator proposals for the east King County crisis response zone. (East zone includes cities: Beaux Arts




Village; Bellevue; Carnation; Clyde Hill; Hunts Point; Issaquah; Medina; Mercer Island; Newcastle; North Bend; Redmond; Sammamish; Snoqualmie; Yarrow Point)

4. One representative selected by the City of Seattle and Sound Cities Association to review youth crisis care center operator proposals. (Note: this representative can be from any regional zone, provided they have expertise in youth behavioral health or crisis services.)

Seattle and the Sound Cities Association must identify these SMEs by September 1, 2024, ahead of a planned CCC procurement in mid-September. The full review panel will convene before the RFP is published for training.

I oversee Human Services at the City of Bothell, recently contracted with Center for Human Services to site a behavioral health clinic in Bothell (leased space), and was a member of the five city coalition team that recruited and helped site the Kirkland Connections center. I was also on the same team that created the new Regional Crisis Response organization. Admittedly, I do not have much capital project experience, but do serve as the Northshore Parks and Recreation Service Area Executive Director, and in that role, we are expending \$9M in voter-approved funds to complete capital repairs in two buildings that house our regional senior center. #### **Applicant Statement:**

Redmond is unlikely to host a CCC site and will be able to provide a neutral perspective in the RFP process. Redmond is committed to being a strong regional partner. Brooke manages the Redmond's homeless outreach team and human services, which includes funding to non-profits for the provision of a variety of services, including behavioral health. She has intimate knowledge of the unique needs in East King County. She has also served on numerous RFP panels, including the recent Health through Housing panel. She leads numerous efforts requiring collaboration and partnership with neighboring jurisdictions and has strong knowledge of and relationships with local service providers.

#### **Applicant Statement:**

I have spent my 25+ year career in the human services and education field supporting marginalized communities. I have experienced first-hand as both a professional and parent the dire need for increased behavioral health resources. 12 years of my career were spent overseeing a wraparound services youth program, which included mental health and substance use disorder treatment. For the past 6+ years, I have worked for the City of Bellevue; as part of my work I oversee the City's human services funding. Through this work, we track data relative to community need. In recent focus groups and a community survey, respondents identified access to behavioral health support as a significant need. This need seems particularly pronounced with Substance Use Disorder services, where only 27% of respondents reported that they were able to access the service within their community (compared to 59% for mental health counseling). Fewer than half (46%) of individuals seeking mental health counseling or substance use disorder services felt that they were able to receive the service in a reasonable amount of time after contacting a provider. I would value the opportunity to be a part of the review panel that will contribute to the critical expansion of behavioral health services in our community, and believe I could bring valuable professional perspective and also personal lived experience, as a parent of children with behavioral health needs.
