SCA Public Issues Committee DRAFT MINUTES November 13, 2024 – 7:00 PM Virtual

1. Welcome and Roll Call

Public Issues Committee (PIC) Chair Chris Roberts, Shoreline, called the meeting to order at 7:02 PM. 24 cities were represented (<u>Attachment A</u>). Guests present included: Katie Halse, Bellevue staff; Gary Simonson, PSRC; Tania Mondaca, King County Council staff; Meagan Jackson, PHSKC; Jessica Jeavons, PHSKC; Dr. Faisal Khan, PHSKC; Eva Wong, PHSKC

Chair Roberts noted that any discussion in the chat for those joining online would be maintained for public records purposes and included in the PIC minutes (<u>Attachment B</u>).

2. Public Comment

PIC Chair Roberts asked if there was anyone in attendance who would like to provide public comment. Seeing none, Chair Roberts closed the public comment portion of the meeting.

3. Approval of the October 9, 2024 PIC Meeting Minutes

Chair Roberts asked for any questions or amendments to the minutes of the October 9, 2024 PIC meeting.

Mayor Sean P. Kelly, Maple Valley moved, seconded by Mayor Nigel Herbig, Kenmore, to approve the October 9, 2024 PIC minutes. There was no discussion. The motion passed unanimously.

4. Chair's Report

Chair Roberts welcomed any PIC members who are joining the meeting from the National League of Cities conference in Tampa.

Chair Roberts provided an update on the SCA Legislative Committee and 2025 SCA Legislative Agenda development noting a draft agenda will be discussed at the December PIC meeting. Chair Roberts also reminded members to send in their respective cities' legislative agendas and priorities as they become available.

Chair Roberts noted that the vote for 2025 PIC Chair and Vice Chair will be held at the December PIC meeting. At the December meeting, PIC will also be voting on appointments to Regional Boards and Committees, as recommended by the PIC Nominating Committee.

5. Interim Executive Director's Report

Interim Executive Director Carl Cole updated PIC on the hire of SCA's newest Policy Analyst, Laura Belmont, Ph.D. Laura's first day will be in December, and they will be introduced at the 2024 SCA Annual Meeting on December 4.

Cole reported on the draft 2025 SCA Budget. The Finance Committee has recommended the draft budget to the Board of Directors. Following the recommendation of the Board, the draft budget will go to the full membership for approval at the 2024 Annual Meeting on December 4.

Cole provided an update on the recruitment for the position of permanent Executive Director.

Cole also provided brief updates on FIFA World Cup planning and potential locations for 2026 games, noting some public safety concerns (e.g. hiring officers for additional security) This discussion will continue at future meetings.

6. Regional Safety Action Plan

Puget Sound Regional Council (PSRC) Senior Planner, Gary Simonson, provided members with an update on the Regional Safety Action Plan (RSAP). Simonson discussed strategies identified in the RSAP for addressing crashes in different emphasis areas. Simonson emphasized that these strategies, and respective examples, can be implemented by cities based on respective safety issues.

7. Public Health Seattle-King County Strategic Plan

Public Health Seattle-King County (PHSKC) Executive Director Dr. Faisal Khan provided members with an update on the 2024-2029 Strategic Plan. Dr. Khan provided an overview of the work that PHSKC engages in to promote public health in the region. This includes, but is not limited to, infectious diseases, food safety, climate change threats, public health clinics, and overdose prevention. The Strategic Plan incorporates the racism is a public health crisis declaration made by the county and utilizes national public health frameworks. Dr. Khan provided an overview of PHSKC's mission, vision, and values, along with the priorities of the new Strategic Plan.

8. Onsite Sewage/Septic Code Revisions

Public Health Seattle-King County staff Jessica Jeavons and Meagan Jackson provided members with a briefing on proposed onsite sewage system (OSS) code changes. PHSKC is required to make revisions in order to comply with changes to WAC 246-272A that were adopted in January 2024. Since this statewide code revision, PHSKC has been working to incorporate the state's changes into King County local codes. The OSS Program is also using this opportunity to propose improvements to King County codes. If the proposed codes are approved by the Board of Health in early 2025, they will take effect in April 2025.

9. Levies and Ballot Measures

PIC Chair Roberts asked members to share any future or potential levies and ballot measures for 2024 and future years. Cities were encouraged to continue sharing their respective levies and ballot issues with SCA staff.

10. For the Good of the Order

Chair Roberts noted upcoming SCA events, and reminded members about the SCA Caucus Meetings on December 12 and December 13.

There were no other items for the good of the order.

11. Adjourn

The meeting was adjourned at 8:37 PM.

Action

Election of the 2025 SCA Public Issues Committee Chair and Vice Chair.

Background

Per the PIC Operating Policies:

Committee Leadership shall be a Chair and Vice-chair elected by the committee. The nominating committee of the PIC shall solicit names for the Chair and Vice-chair of the PIC and make a recommendation to the PIC by December 15th of each year. The Chair may serve a one year term with a two term maximum.

The PIC Chair serves a one-year term, and may serve up to two consecutive years. The Vice PIC Chair serves a one-year term, and may serve up to two consecutive years. The current PIC Chair, Mayor Chris Roberts, Shoreline, and current Vice Chair, Councilmember Joseph Cimaomo, Jr., Covington, are each in their first terms and each has indicated their interest in continuing in their positions.

The PIC Nominating Committee met on November 26, 2024 and reviewed nominees for 2025 PIC Chair and Vice Chair. The Nominating Committee recommends the election of Mayor Chris Roberts, Shoreline, as PIC Chair, and the election of Councilmember Joseph Cimaomo, Jr., Covington, as PIC Vice Chair.

Next Steps

The full PIC will vote to elect a 2025 PIC Chair and Vice Chair at the December 11, 2024 PIC meeting.

Action

The PIC Nominating Committee met on November 22, 2024 and November 26, 2024 to develop a list of recommended 2024 SCA Board and Committee Appointments for consideration by the PIC (<u>Attachment A</u>). The PIC is anticipated to take action at the December 11, 2024 PIC meeting to recommend appointments to the SCA Board of Directors, who will consider PIC's recommendations at their meeting on December 18, 2024.

Background

A nominating committee of the Public Issues Committee (PIC) consisting of one representative of each SCA Regional Caucus (South, North, South Valley, and Snoqualmie Valley) is appointed annually by the Chair of the PIC, and makes recommendations to the PIC on appointments. The PIC in turn makes recommendations on regional board and committee appointments to the SCA Board of Directors.

Per SCA Bylaws, appointees to major regional committees shall be selected from among elected officials otherwise qualified to serve in such positions, in accordance with the terms of the enabling documents creating such boards and committees. Appointees shall represent the positions of all SCA member cities. Equitable geographic distribution shall be considered in recommending appointments to the Board of Directors.

No member shall serve more than six (6) consecutive years on a regional board or committee appointed by SCA. This limitation shall not apply to alternates to regional boards and committees. Once a member has served six (6) consecutive years on a regional board or committee, they shall be ineligible to serve on said committee for a minimum of one (1) year. Pursuant to a bylaw amendment adopted on December 2, 2015, "In extraordinary circumstances, the Board may make exceptions to the six-year term limit upon the recommendation of the PIC nominating committee and the PIC when a supermajority (2/3) of Board members present and voting at a meeting finds that doing so would be in the best interests of SCA and its member cities."

The PIC Nominating Committee met on November 22, 2024 and November 26, 2024 to develop a list of recommended appointments for consideration by the PIC. <u>Attachment A</u> provides those recommendations. Included in the Nominating Committee's recommendations is a finding of extraordinary circumstances to make an exception to the six-year term limit for the following appointments:

- Marli Larimer, Kent as member to the Advisory Council on Aging and Disability Services
- Nancy Backus, Auburn as member to the Greater Seattle Partners
- Dana Ralph, Kent as member to the PSRC Transportation Policy Board
- Angela Birney, Redmond as member to the Regional Policy Committee

The following committee positions remained unfilled following the Nominating Committee's meeting on November 26. A call for nominations will go out in 2025 to fill these vacancies.

- Domestic Violence Initiative Task Force (2 Alternates)
- Joint Recommendations Committee (1 Member / 2 Alternates)

Next Steps

Following action by the PIC, recommendations will be forwarded to the SCA Board for final approval at their next meeting on December 18, 2024.

Discussion

At the December PIC meeting, the King County Solid Waste Division (SWD) will brief members on the Long-Term Disposal (LTD) Study.

SWD has enlisted TetraTech to evaluate five LTD options and for implementation in 2040-2060. Throughout the study, TetraTech has briefed the Metropolitan Solid Waste Advisory Committee (MSWAC), Solid Waste Advisory Committee (SWAC), and an LTD subgroup of city and agency staff. In November, TetraTech gathered feedback from MSWAC, SWAC, and the LTD subgroup on the draft report, which is set for finalization by January 2025.

Multiple levels of advisory, community, and city engagement will occur over the coming years to discuss TetraTech's recommendations, with a final decision on the LTD option by the King County Executive in 2027.

Background

Washington State law mandates each county to create a coordinated plan for regional waste management. King County's Comprehensive Solid Waste Management Plan (Comp Plan), adopted in November 2019, sets goals and strategies for the next 6 years while considering a 20-year outlook. The King County Solid Waste Division (SWD) reviews this plan every 3 to 5 years.

In 2019 the regional solid waste system serving 37 cities and unincorporated areas updated its Comp Plan, which included:

- A review and update to solid waste management goals, policies and actions
- Specific guidance for analyzing long-terms disposal options including evaluation criteria
- Three long term disposal (LTD) options: (1) waste export, (2) waste to energy/mass burn, and (3) maximization of the landfill
- Selected maximization of the landfill as the primary option for long term waste disposal

Two consultant studies were used to inform the LTD discussion during the 2019 Comp Plan. After the Comp Plan was adopted, another study comparing waste to energy and waste export was also completed. These studies were shared with the new Comp Plan consultant group, TetraTech, as a starting point for evaluating LTD options for the current Comp Plan update.

LTD Study

As part of the next Comp Plan update, TetraTech has conducted an LTD Study assessing five LTD options. This Study is meant to guide SWD and ILA partners in decision-making and planning for 2040-2060. The evaluated LTD options include:

- 1. **Refuse Derived Fuel (RDF)**: mixed solid waste (MSW) processing using shredders, screens, magnets, and eddy current separators to produce a combustible feedstock that could replace fossil fuels in industrial settings
- 2. **Gasification:** Thermal conversion process that transforms MSW into a synthetic gas (syngas) that can be used as a fuel, or made into industrial chemicals such as ammonia and methanol, fertilizer, etc.
- 3. **Pyrolysis:** Thermal conversion process under high pressure conditions that transforms MSW into usable products typically oils, solid carbon/char and other chemicals.
- 4. **Mass Burn**: Combustion of MSW to create heat that can be made into superheated steam for industrial processing, generating electricity and/or district heating. *Note*: mass burn has a waste export by rail element.
- 5. **Waste Export by Rail (WEBR):** Transporting MSW by train to a regional landfill outside the County for burial and landfill gas collection.

The criteria established for reviewing LTD methods/options includes 6 categories:

- Economic Impact how expensive is the method to implement?
- Environmental impact how does this method impact climate, water, air, health, etc.?
- Social impact how does the method impact livability in local neighborhoods?
- Capacity how does the method handle different waste tonnages and types?
- Operating history what is the method's historical record in performance, safety, compliance?
- Logistics how easily does the method fit into King County systems?

Based on economic, operating history, capacity and environmental criteria, SWD and TetraTech removed RDF, gasification, and pyrolysis from further consideration in the LTD decision process. The last two LTD options for consideration are mass burn and WEBR. Key findings on mass burn and WEBR are detailed below.

<u>Mass Burn</u>

- Established technology with a proven track record of 40 years for quantities and types of waste projected for King County.
- Mass Burn costs are much higher than WEBR for the study period. Capital: \$1.2 billion; Operational: \$54 million + \$23 million ash disposal; Cost per Ton of \$231 (2040\$)
- Life Cycle Analysis (LCA) shows benefits in non-renewable energy demand, acidification potential, smog formation potential, and water consumption (with caveats). However, LCA shows detriment in global warming and cancer potential.

- Energy from Mass Burn is generally prohibited from being used within the State due to the Clean Energy Transformation Act.
- Difficult to site and permit. Several recent closures of Mass Burn facilities on the West Cost. Process generates emissions needing management and intensive permits. Difficult siting and high public opposition due to pollution concerns.
- Financially disincentivizes lowering tonnage throughput (not very compatible with Re+).
- Reduces waste 75% by weight, however, ash residuals would need to be transported by rail (WEBR).

Waste Export by Rail

- Proven disposal option in Washington State for over 30 years.
- Capital: \$3.3 million; Operational: \$72 million; Cost per Ton of \$108 (2040\$)
- Can utilize existing infrastructure, so no need to site and build a new facility.
- Railroads prefer contracts of 5-10 years. Future pricing projections are difficult and exposes County to risk.
- LCA shows benefits in water consumption and is neutral in cancer potential.
- Can more easily accommodate changing tonnage amounts (more compatible with Re+).
- King County tonnage and expected rail use growth should not significantly impact rail capacity.

Engagement

Monthly Metropolitan Solid Waste Advisory Committee (MSWAC) and Solid Waste Advisory Committee (SWAC) meetings have served as primary forums for discussing all LTD options. An LTD sub-group from MSWAC was established to investigate LTD information, answer city questions, and discuss recommendations for MSWAC. This sub-group has met four times, including a review of the LTD analysis with TetraTech, and feedback provided on the draft study. SWD also held two open houses for cities, staff and interested parties.

Next Steps

TetraTech will finalize the report in January 2025 and commence the SEPA process. Dates for the scoping and EIS comment periods are pending. TetraTech plans to brief cities in early to mid-2025 and will keep MSWAC, SWAC, and the LTD sub-group updated. Advisory committees will decide on the final option by early 2027, with the King County Executive's decision to follow.

Legislative Guiding Principles
