#### 1) Call to Order

SCA President Mary Lou Pauly called the meeting to order at 10:08 AM Present were members Traci Buxton, Armondo Pavone, Wendy Weiker, Jan Molinaro, De'Sean Quinn, Troy Linnell, Katherine Ross, Dana Ralph, and Regan Bolli, and SCA staff Carl Cole, Leah Willoughby, Andie Parnell, and Aj Foltz. Absent were members Amy Falcone, Mason Thompson, and Chris Roberts.

#### 2) Public Comment

President Pauly asked if there were any members of the public present for public comment. Hearing none, this portion of the agenda was closed.

#### 3) Consent Agenda

President Pauly asked for any questions or concerns regarding the items on the consent agenda.

#### Discussion

At the December SCA Board of Directors meeting, the Board will discuss the process and preferred next steps to appoint an individual with lived experience with homelessness to the King County Regional Homelessness Authority Governing Board (GB). The deadline for this appointment is early 2025.

Per KCRHA's updated Interlocal Agreement, SCA has appointment authority for one individual with lived experience with homelessness to the GB. KCRHA has created their own recruitment process consisting of an application and interviews to assist all appointing entities in choosing their lived experience representative. The SCA Board members have discretion on how SCA will proceed in the recruitment process, alongside KCRHA.

#### **Background**

This year, King County Regional Homelessness Authority (KCRHA) approved a revised Interlocal Agreement (ILA) that streamlined the governance structure of the organization. Previously, KCRHA was governed by two Boards, the Governing Committee, composed of elected officials, and the Implementation Board, composed of subject matter experts and individuals with lived experience. The new ILA creates a single Governing Board (GB) responsible for setting strategic policy direction, providing fiscal oversight, monitoring performance metrics, and ensuring the authority is making progress to fulfill its mission.

SCA has authority to appoint one individual with lived experience with homelessness to the GB. KCRHA has offered to assist with this process by providing a pool of individuals for the SCA Board to select to interview. However, the SCA Board has discretion on SCA's internal selection process for this seat and whether to send out a call for nominations/recommendations to the SCA network or limit recommending authority to the Board.

#### **Lived Experience Definition**

The applicant must meet the following requirements in order to be eligible for this appointment. Members must have lived experience *and* demonstrable expertise in one or more of the areas specified below:

- Implementation of policies and practices that promote racial-ethnic equity within an organization of similar size and responsibility as the Authority
- Fiscal oversight of entities with budgets of similar size to the Authority
- Direction or oversight of business operations and/or strategy of a large public or private entity or organization
- Federal Continuum of Care program governance and operations
- Provision of services for persons experiencing homelessness or related social services with an emphasis on serving populations disproportionately represented among those experiencing homelessness and
- Academic research on topics related to homelessness and/or performance evaluation.

#### **Recruitment Process**

KCRHA staff have offered to screen candidates for this appointment in order to expedite recruitment for this seat. They are currently gathering applications online with the deadline to submit on December 20 (deadline may be extended at KCRHA's discretion). From there, KCRHA will recommend a group of candidates to the SCA Board of Directors. Detailed information is laid out in Attachment 8.

SCA can conduct their own recruitment activities alongside KCRHA's process in order to expand the pool of individuals under consideration. All candidates will need to be screened and interviewed equally. SCA can have interested individuals fill out the KCRHA Governing Board Lived Experience Application ( <a href="https://example.com/Attachment9">Attachment 9</a> ). The Board of Directors will then interview selected candidates from the pool utilizing the KCRHA GB Interview Questions ( <a href="https://example.com/Attachment10">Attachment 10</a> ).

Notably, the SCA Board of Directors has the sole authority to appoint an individual to this seat. The Board does not have to select an individual screened by KCRHA staff. However, having all interested individuals submit the application and participate in an interview ensures equity in the recruitment process.

#### **Process Timeline**

- December 20 (may be extended): KCRHA recruitment application deadline
- Mid-December to Early January: SCA staff sends out a call for nominations to recruit applicants\*
- January Board of Directors meeting:
  - o First look at candidate pool from SCA network and KCRHA staff
  - o Discussion of SCA considerations for this seat
- Mid-January to Mid-February: Interviews with selected candidates
- February Board of Directors meeting:
  - Approve final appointment to KCRHA GB

O Individual is notified and will attend the next KCRHA GB meeting

\*Needs Board direction: Should SCA staff put out a call to the SCA network this month to distribute the application materials? Or should the Board and the SCA GB Caucus members have sole discretion over recruitment?

#### **Next Steps**

Pending feedback from the Board regarding this process, SCA staff will start outreach to collect applications for this appointment. Once KCRHA has reviewed their pool of applicants, they will send potential candidates to SCA staff. SCA staff will compile the applications and send them to the Board for review a week before the next Board meeting.

  - Provision of services for persons experiencing homelessness or related social services with an emphasis on serving populations dipropionate represented among those experiencing homelessness and
  - Academic research on topics related to homelessness and/or performance evaluation.
