Q. How do I get on PIC?



Membership of PIC: one representative and one alternate from each member city.



Each representative or alternate must hold an elective office in the city or town they represent.



The process by which each city appoints their rep and alternate is at the discretion of each individual city.

Q. Who decides who gets appointed to regional boards and committees?



Per SCA bylaws, the PIC Nominating Committee, made up of one representative from each SCA caucus (North, Snoqualmie Valley, South, and South Valley), makes initial recommendations on appointments to the PIC.



The PIC in turn makes a recommendation to the SCA Board.



The Board makes the final appointments.

Q. When do I apply?





A call for nominations will be sent in the fall for 2026 committee seats.

There will also be mid-year calls for vacancies.

Q. Are there any vacancies now?

Yes! We have existing or expected vacancies on:





SCA appoints members and staff to numerous regional boards and committees. PIC gives policy direction to those committees.



Public Issues Committee (PIC)

- Representative of each city in SCA appointed by their respective councils
- "Policy-making arm" of SCA
 - The body responsible for making recommendations on policies and committee appointments to the Board
 - SCA's vehicle for informing member cities of regional programs and policies, and for member cities to share their respective concerns and insight
- SCA Legislative Agenda development

How do issues come before the PIC?

From SCA members, via:

- Regional boards and committees
- SCA Board
- PIC Chair/Vice Chair
- Previous PIC discussions
- SCA Mayors meetings, Deputy Mayors meetings, City Managers meetings, individual city council meetings, etc.

How is a policy position established?

- "Two-touch rule"
 - And sometimes three!
- PIC discusses item, votes on whether to bring back for possible adoption at next meeting
 - Exception: emergency action
- PIC members bring item back to their individual cities (staff, mayor, council) for discussion and vetting
- Policy comes back to PIC at next meeting for vote
- Policy forwarded to Board for adoption





Policy direction to committee members:



- Represent the common interests of all cities
- Should not take policy positions that are harmful to the interests of any member city, even if favored by a supermajority of members.

Participating in Caucus Discussions

Work towards a consensus decision

Respect the positions of fellow caucus members View issues from a regional perspective while considering what is best for your city

Review agenda and materials provided by policy staff to prepare for the discussion

SCA Caucus is a safe space to share opinions and discuss regional policy!

Attendance

- Board Policies 701.5
 - 75% attendance at both caucus and regional committee meetings expected
 - $_{\odot}$ If an appointee misses 30% of meetings, SCA will check in
 - $_{\odot}$ At 50% absence, the Board may ask for a resignation
- Bylaws 4.16.7(g)
 - $_{\odot}$ If absent for three consecutive meetings, may be removed by a 2/3 vote of Board at any time during term

Regional Staff Roles & Contacts

Committee Staff

• Many committees have primary staff who send out caucus agendas and manage content. SCA Policy Staff maintain close relationships with these individuals.

Staff in Caucus Meetings

• Occasionally, regional staff from member cities join caucus meetings of which their representatives are appointed. These staff often have subject matter expertise and can provide additional policy information to inform caucus decisions.

SCA Policy Staff Relationships

• Your policy staff at SCA build and maintain relationships with many regional entities. We act as a liaison for our members, and can bring questions or considerations to these individuals on behalf of our membership.
